**2024 FEE PAYMENT OPTIONS:** (Please see tables above for the Annual, Termly, and Monthly fee structure)

**ANNUAL:** Standard tuition fees, Aftercare fees and the Annual Operational Levy are billed per school year and are due by 1 January 2024. A limited number of discounts on annual payments, equal to one month's Standard Tuition fee will be offered to clients paying in advance and in full by 20 December 2023.

**TERMLY:** Standard tuition fees and Aftercare fees are billed per school term and is payable by the due date stated on the termly invoice.

**MONTHLY:** Standard tuition fees are billed over 11 months from January to November and are due by the 1<sup>st</sup> of each month. Aftercare fees are billed over 10 months from February to November and are due by the 1<sup>st</sup> of each month.

Please contact [finance@waldorfschool.org.za](mailto:finance@waldorfschool.org.za) by the **1<sup>st</sup> of December 2023**, if you are considering paying tuition and/or aftercare fees annually or termly in 2024 to ensure your account is invoiced accordingly.

**ADDITIONAL CHARGES:**

Additional charges for services not included in the Standard tuition fees will be invoiced as and when they occur and are payable on or before the invoiced due date. Additional charges may include but are not limited to: Casual aftercare charges; Class camp and transport costs; Extra mural activities or outing costs; Textbooks.

### METHODS OF PAYMENT:

1. Monthly Debit Order or Stop Order payments over 11 months (January to November) is our preferred payment method.
2. Monthly payments may also be made via Electronic Transfer over 11 months (January to November).
3. Annual and Termly invoices are payable by Electronic Transfer on or before the invoiced due date.
4. Payment of fees by any method other than Debit Order, Stop Order or Electronic Transfer need to be arranged with the Administration Office and must be agreed to in writing with the Board of Trustees before coming into effect. 5. Fees are payable in South African Rand, free of commission and bank charges. Any bank charges and transaction costs from third party providers are payable by/chargeable to the client.

### LATE PAYMENTS:

Failure to pay fees by the 1<sup>st</sup> day of each month, with payment not reflecting by the 3<sup>rd</sup> day of that month, will result in the commencement of our Debt Collection process. Late payment interest of 2% per month will be charged from the due date, compounded monthly.

### WITHDRAWAL NOTICE:

A minimum of one month's written notice is required when intending to withdraw a student from the Stellenbosch Waldorf School. Should the written notice not be received in due time, an invoice equal to one month's tuition and aftercare fee where applicable, will be issued in lieu of notice and all parties who signed the Agreement of Enrolment form and Aftercare form will remain liable for the payment of the outstanding account.

### DECLARATION:

The Board of Trustees of the Stellenbosch Waldorf School reserves the right to adjust the school fees and related charges from time to time, as it may deem fit.
