ENROLMENT FEE:

A **non-refundable, once-off enrolment fee** is payable in advance upon enrolment at the School.

ANNUAL GENERAL SPECIAL LEVY:

R1000 per child, payable by 7th January of each year, which will cover additional sundry costs including but not limited to consumables, sport, etc.

FEE PAYMENT OPTIONS:

One of these options must be selected for the entire year:

ANNUAL: 5% discount is offered for annual fees settled before 31st December each year.

MONTHLY: Playgroup, Kindergarten and Classes 1 – 12:

Billed over 12 months from January to December, payable on the 1st day of each month via direct debit (please complete the debit order instruction attached).

Class 13:

Billed over 11 months from January to November, payable on the 1st day of each month.

MONTHLY INVOICES:

The following will appear on the school invoices as and when they occur and are payable within one month of being charged unless arrangements are made with Natasja Meyer, our Financial Administrator.

- Camp fees
- Textbooks
- Outing fees and transport
- Transport for extra murals/matches
- Remedial and support fees
- Curative Eurythmy fees
- Aftercare fees

LATE PAYMENTS:

A late payment charge will be levied at the rate of prime + 2% from the invoice date, on all accounts not settled by the 7th day of each month.

NOTICE PERIOD:

One month's written notice is required when intending to withdraw a child from the school.

Both parties who have signed the Agreement of Enrolment form remain liable for the payment of all outstanding accounts unless other written agreements are lodged with the Finance Office.
